RE: NYSDEC Receipt of an Application for Water Quality Certification Constitution Pipeline FERC Docket Nos. CP18-5 and CP13-499

Dear Chief Amy L. Gitchell:

New York State Department of Environmental Conservation (NYSDEC) is hereby notifying the U.S. Army Corps of Engineers (USACE) of the receipt of a request for a Water Quality Certification (WQC) pursuant to Section 401 of the federal Clean Water Act (CWA) related to the construction, installation, and operation of the Constitution Pipeline project (Project), which would be subject to the federal Natural Gas Act.¹ This WQC request was submitted to NYSDEC on May 30, 2025.

NYSDEC understands that, based on Executive Order 14156, issued January 20, 2025, and the associated emergency procedures established by USACE,² a Reasonable Period of Time (RPOT) of 25 days would be requested for NYSDEC to act on this WQC request. However, due to the regulatory timeframes associated with processing all WQC requests,³ NYSDEC cannot meet a 25-day RPOT. As such, and in accordance with the plain language of the CWA and the USACE emergency procedures, NYSDEC is confirming a RPOT of six (6) months to act on this WQC request is in effect pursuant to 40 CFR 121.6(c).
